## **Céline Byl has moved to Head of Group Strategy and Julia Deiva has been appointed Head of Investor Relations**

Julia Deiva has been appointed Head of Investor Relations at CNP Assurances. In her new role, she is responsible for CNP Assurances' financial communication and in charge of relations with investors and financial ratings agencies.

Julia Deiva reports to Sarah Bouquerel, Deputy Chief Executive Officer and Group Chief Financial and Non-Financial Officer of CNP Assurances.

She succeeds Céline Byl, who is now focusing on her role as Head of Group Strategy and will oversee the roll-out of the 'Lead for Impact 2026–2030' strategic plan. Céline Byl reports directly to Marie-Aude Thépaut, Chief Executive Officer of CNP Assurances.

### **Biography of Céline Byl**

A qualified actuary with a Master's degree in scientific management methods and in economic and management modelling, Céline Byl began her career in 2006 at CNP Assurances in the Group Technical Department, as an actuary before taking over responsibility for the Savings Division in November 2011. She joined the BPCE Business Unit in 2014 where she was Head of the Actuarial and Steering Department for seven years. In 2021, she was appointed Head of Supervision and Coordination of Subsidiaries and then became Head of Investor Relations at CNP Assurances, a position she combined with that of Head of Strategy from April 2024. Since March 2026, Céline Byl has been Head of Group Strategy at CNP Assurances.

Julia Deiva holds a Master's degree in mathematics from the University of Lyon and a DESS in actuarial and financial sciences from ISFA. She began her career in 2002 at Mazars Actuarial. In 2004, she joined the Societe Generale group's life insurance and capitalisation company (SOGECAP), where she carried out various activities relating to the management of results and profitability. In 2014, she was named Head of Technical Reporting, Profitability and ALM at AGEAS France. In 2020, she was appointed Head of Retirement Savings in the Technical and Innovation Department of CNP Assurances. In 2023, she became Chief Financial Officer of CNP Unicredit Vita in Italy. In July 2025, she was appointed Deputy Product Offering and Development Director for the La Banque Postale business unit of CNP Assurances. Since 1 March 2026, she has been Head of Investor Relations at CNP Assurances.
